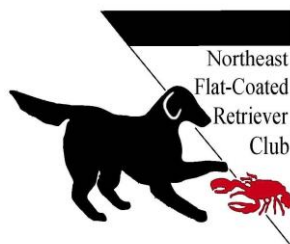

Scratch Fee: Entry refund minus \$4 per dog/ per entry will be given for dogs scratched due to injury or bitches in season. All such refund requests must be accompanied by a veterinary certificate and must be submitted to the test secretary within (10) days of test completion.

Bitches in season are not allowed to run or be present on the test grounds.

FCRSA and GRCA rules allow for the possibility that wingers may be used in the WCX test but not the WC. Popper guns will be used at all dead bird stations.

Lunch will not be available on the test grounds, so please bring your own food, beverage and water. Lunches will be provided for workers.
Exhibitors must provide their own chairs. Don't forget sunscreen, insect repellent, water for your dogs, etc.

No alcoholic beverages will be allowed on test grounds.

Important Request for Your Cooperation

While using the property at West Thompson Lake, keep in mind that we do not have exclusive use of this area for our test. Other people and dogs may be hiking through. Be cordial and be sure to keep your dogs under control at all times. Observe the 10 mph speed limit (it is enforced!). Do not leave ANY litter behind and be careful with matches and smoking materials. When you enter the property, please close the gate after you pass through.

### Directions

From the West: CT Route 44 east, to Route 12. North on Rt. 12. Left onto West Thompson Road (at traffic light) at intersection of Rt. 12, 193, and West Thompson Road. See Local Directions.

From the South: I-395 North to LEFT Exit 7. Left on Riverside Dr (CT-12). In 0.7 miles, Right on W. Thompson Rd. See Local Directions.

From the North: I-395 South to Exit 50. Left onto Rt. 200. Right onto 193. Straight across Rt. 12 at traffic light. You are now on West Thompson Road. See Local Directions

Local Directions — After crossing the dam and passing the fire station, turn right on Ravenelle Road. Entrance gate is immediately on right. Close gate behind you. Gate must remain closed. Follow FCR signs to the training site. Please obey posted speed limit.

### Effective Immediately

The GRCA board requires entries in the WC/WCX and CCA to send a copy of the dog's AKC/CKC registration with their entry forms. This is due to errors on entry forms with the spelling of dog's name, AKC number, etc. The yearbook staff must verify the dogs and their sires and dams for accuracy, and by submitting a copy of their registration, it will help immensely.

Event secretaries will send a copy of the AKC registration of all **Goldens passing** the WC/WCX test with the event's final report to their WC/WCX regional representatives.

Left out of the test site gates and Right on W Thompson Rd. Continue straight onto Woodstock Ave. Slight left to stay on Woodstock Ave. Continue onto Harrisville Rd. Turn Right to stay on Harrisville Rd. Turn Left onto CT-169 S. Turn Right onto CT-97S. Continue straight onto CT-244 W. Turn Left onto CT-198 S. Turn Right onto US-44W. Continue onto US-44 W/ US-6 W. Take the US-6/US-44 W exit toward Bolton. Continue onto US-44 W/US-6 W. Hospital will be on the right.

Left out of the test site gates and Left on W Thompson Rd. Go over the Dam and down to the traffic light. At the traffic light, turn left onto Riverside Drive (CT-12). Go to stop sign and turn right, going up the ramp onto I-395 South. Take exit 37A toward Providence onto Providence Pike (US-6 East). Continue to follow US-6 East. Continue on Grand Army of the Republic Highway (US-6A). Take ramp onto I-295 South toward Warwick. Merge onto I-95 South. Take Exit 8A/Quaker Lane onto Quaker Lane (RI-2). Continue to follow RI-2. Arrive at 1480 South County Trail, East Greenwich, on the Left past the intersection.
